- 8. THE COURT WILL CONDUCT A FINAL APPROVAL HEARING ON JULY 27, 2016 AT 1:30P.M. TO DETERMINE THE OVERALL FAIRNESS OF THE SETTLEMENT. THE FINAL APPROVAL HEARING MAY BE CONTINUED WITHOUT FURTHER NOTICE TO CLASS MEMBERS.
