**KENTFIELD SCHOOL DISTRICT  
 2019-2020 REQUEST FOR PARCEL TAX EXEMPTION**

An exemption from the Kentfield Parcel Tax assessment will be made available to homeowners who will attain 65 years of age as of June 30, 2019 or homeowners receiving Disability Supplemental Security Income. Eligible homeowners may apply for the exemption prior to June 30<sup>th</sup> of the assessment year. Eligibility is defined as the owner-occupant who owns a beneficial interest in the parcel, and who uses that parcel as his or her principal place of residence and who applies to the District on or before June 30, 2019 for the 2019-2020 tax year. Any one application from a qualified applicant will provide an exemption for the parcel tax for the remaining term of the assessment so long as such applicant continues to use the parcel as his or her principal residence.

**Filing date for the exemption to take place for the 2019-2020 fiscal year is July 1, 2019.**
