The following are the **Income Guidelines for Exemption to City of Mill Valley 2023-24 Library Tax**:

1. The property must be owner occupied.
2. The total **gross household income** from all sources, including social security, for the 2022 calendar year does not exceed the following:

For a single-person household:	\$116,200
For a two-person household:	\$132,800
For a three-person household:	\$149,400
For a four-person household:	\$166,000
For a five-person household:	\$179,300
3. In order to meet the deadline to qualify for the exemption on your September, 2023-24 tax bill, **you must file your request by May 31, 2023.**
4. **You must reapply each year** to keep the exemption in effect. A form will automatically be sent to those who filed the previous year.

If you qualify, please complete and sign the **Declaration of Exemption to City of Mill Valley 2023-24 Library Tax Form** on the reverse side of this page. Once completed, return the form by May 31, 2023 to:
