The following are the <u>Guidelines for Exemption to City of Mill Valley 2025-</u> **26 Municipal Services Tax:**

- You must be at least 65 years of age by the time of filing and reside in an owner-occupied single-family residential dwelling.
- 2. The total **gross household income** from all sources including social security for the 2024 calendar year did not exceed the following:

For a single person household: \$130,600

For a two-person household: \$149,300

For a three-person household: \$157,950

For a four-person household: \$186,600

3. In order to meet the deadline to qualify for the exemption by your 2025-26 tax bill, you must file your request by May 31, 2025. You must reapply each year for the exemption. A form will automatically be sent to those who filed in previous years.


What is the MST?

The City's Municipal Services Tax funds our long-term program of street rehabilitation and fire prevention services, including:

- Maintaining, repairing and improving streets (safety curbing and striping, regular repaving of most-traveled streets, and improving lesstraveled streets).
- Preventing wildfires by removing brush and vegetation, creating fire breaks, and improving emergency vehicle access.

The funds generated by this tax have improved the condition of city streets and storm drains, reduced fire hazards, and shortened emergency response times.
