Parcel Tax Senior Exemption Application Instructions

Dear Property Owner,

Attached is an application form for senior exemption from the Nicasio School District Parcel Tax charge. Please complete and sign this application and send it to our office, along with copies of the following required supplemental documents:

- ✓ **Proof of Your Birth Date** (i.e. copy of driver's license, state identification card, passport or birth certificate)

- ✓ **Proof of Residence**
If your identification lists an address OTHER THAN that for which you are requesting the exemption, you must submit a second document that details your name and the physical address of the property (i.e. utility bill such as PG&E, phone, garbage, etc., or a recent homeowner's insurance bill dated within the past six months).

- ✓ **Pages from Trust Instrument** (*for Beneficial Owners only*)
If ownership of your home is held under a trust instrument (TR) please submit copies of the following pages:
 1. First page;
 2. The page that names you as Beneficiary of the Trust or the page that states the trust is to be applied for your benefit;
 3. Signature page;
 4. Property description – The page within your trust (Exhibit/Schedule) that references the parcel number, lot number(s) for your property, or physical address of the property.
